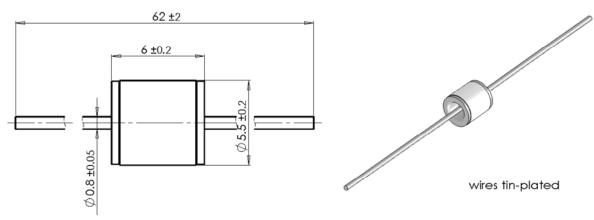



Dimensional drawing in mm

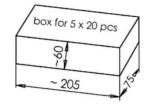




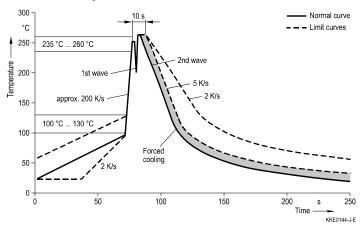
