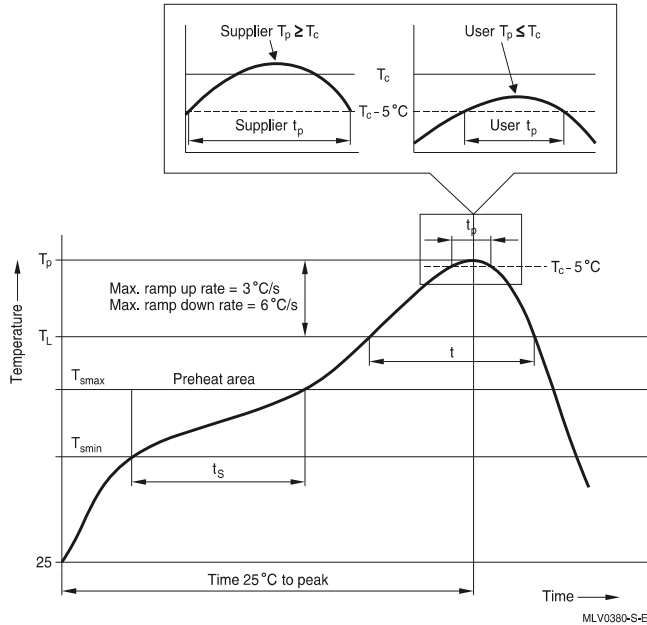

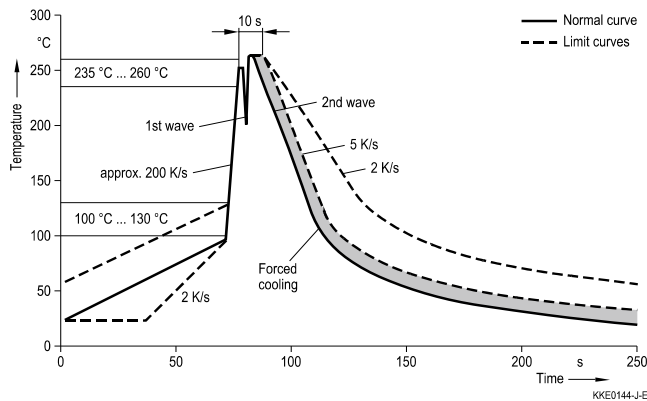

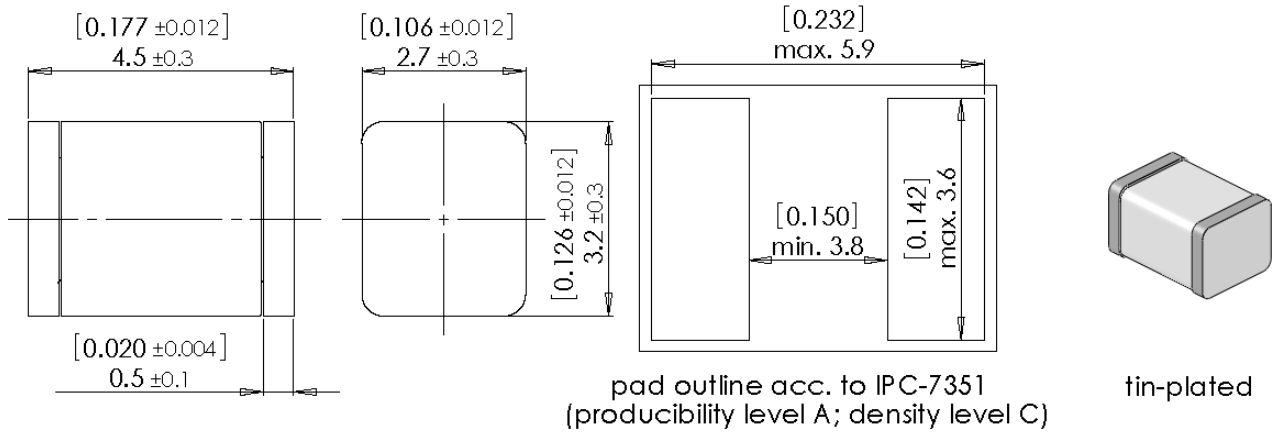

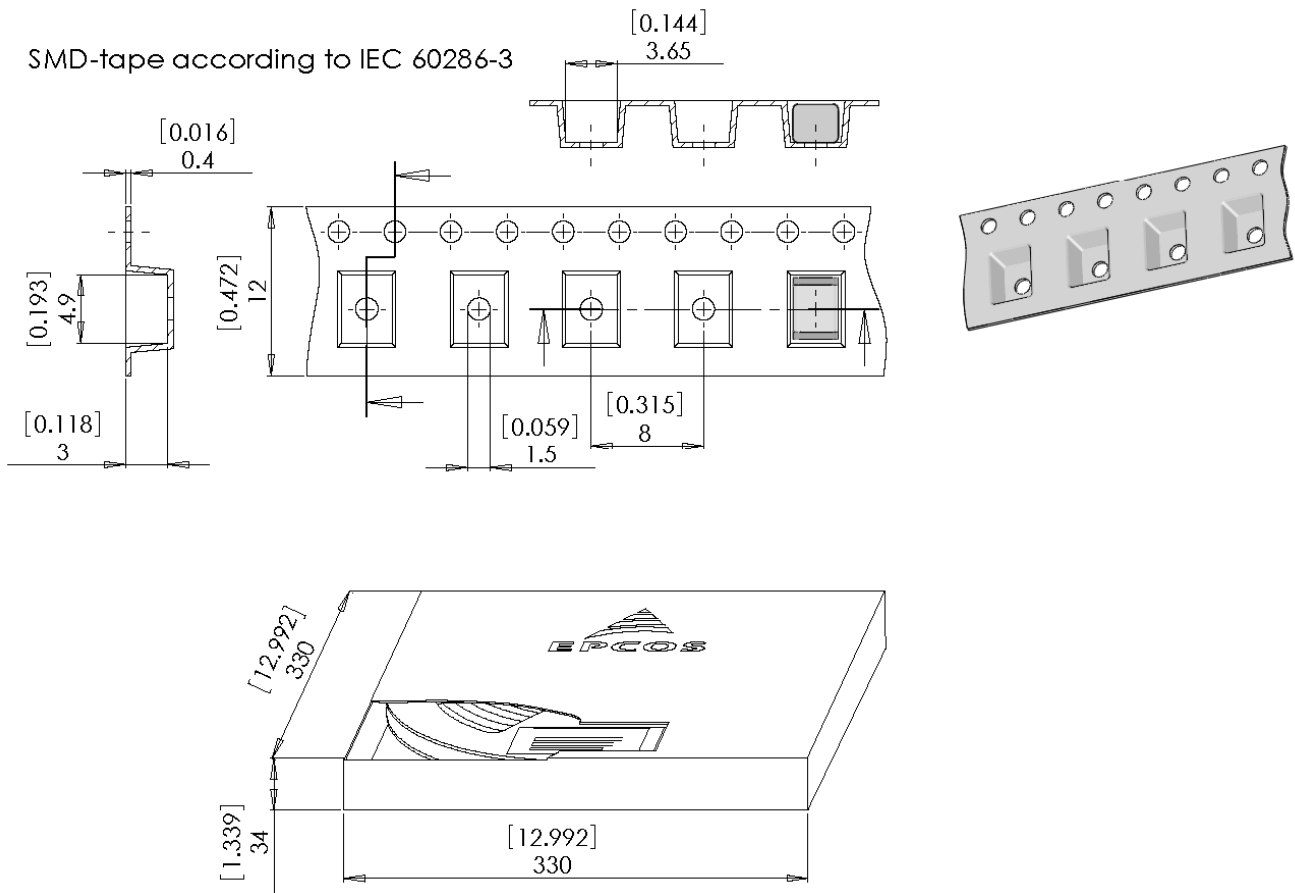
Soldering profile applied to a single soldering process.
