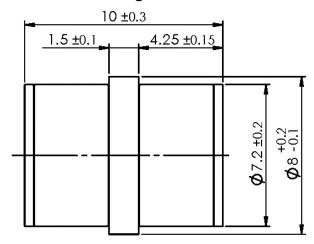

Dimensional drawing in mm

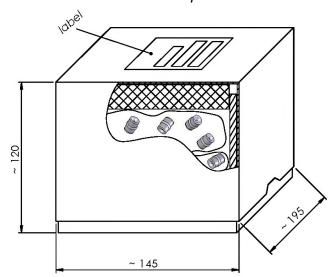
